## Kinsman Township Trumbull County Records of Proceedings

## Work Session Held on January 6, 2024, at 10:00 A.M.

Chairman Bruce Bancroft opened the work session meeting.

All present stood to recite the Pledge of Allegiance to the flag.

Fire: Travis Sapp and Chad Thompson attended the work session meeting. Travis told the trustees that a State Fire Marshal grant has opened for \$15,000 with no match. They are planning on applying.

There is also an ODNR grant that has opened. The department can write a grant request for a skid unit or wildland gear jumpsuits. They are looking to see if there is a possibility of purchasing a new brush truck. They currently have a 1991 F250 brush truck. It is not suitable to use the SUV with a trailer for brush removal.

Travis told the trustees that they have written grants four times for FEMA for a brush truck and have been denied each time. A 2023 F250 XL brush truck at Valley Ford state purchase is \$55,000 with lights and graphics estimated at \$7,000.

The SUV gets utilized for traveling and training.

The fire department does well with grants, and they are looking for a grant to replace the SCBA bottles, about 10 or 12 of them. The air packs are in good shape. They would like to replace some cylinders and hose.

Travis has started to reach out to organizations to come to Safety Forces Day hoping that more people can come out. It will be held the third Saturday of June. Preparation begins in January. Bruce will go to the fire department meeting on Tuesday at 8 p.m. to discuss possible housing of police vehicles.

Travis told the trustees that it has become more difficult to recruit young volunteer firefighters. The trustees thanked Chad and Travis for their work.

Road: Tim Tricker and Vince Peterson discussed their plans for the road project this year. It is important that the roads need to be resealed in town, mostly tar and chip. The cost of tar and chip is about \$15,000 per mile. If they can have half of the roads done that would be great, double-layer chip seal.

The cost is estimated at \$170,000. Marge told the trustees that we could probably do that. Vince spoke with the county engineers regarding weight limits on several roads. They are waiting for the engineer's studies to post them. Weight limit signs need to be posted on both sides of Ward Christy Road. They need to take photos of the damage and document it when it happens.

Ward North is being destroyed by overweight trucks. Ward Christy did not get in on the weight study with Ward North. We have heard nothing on speed limit requests yet.

Ray State Line Road needs paved but suggesting tar and chip. Greene Township in PA takes care of the West Salem portion of Turner Mullen Road. It is Kinsman's turn to maintain Corinth Court this year.

Tim and Vince discussed Road equipment. The boom mower main pin will probably go soon and the flail mower head needs to be rebuilt.

The trustees will plan to pay Vince Peterson \$21.50 per hour beginning in January, and they will discuss it further on Monday at the reorganization trustees' meeting.

The trustees will hold off on advertising for a full-time road worker until before April when Tim leaves. He will continue his present salary until he leaves then.

The trustees expressed their gratitude for all the road workers continue to accomplish for the township.

Vince will be attending the reorganization meeting. Vince told the trustees the backhoe cylinder shafts need to be re-chromed. He can replace the bushings to save money.

The new mower will arrive sometime in January.

Greg asked Tim and Vince to put together this year's road project for bid as soon as possible. The trustees thanked Tim and Vince for their continued fine work in the road department.

Zoning- Mark told the trustees that we didn't have as many zoning permits as last year. He wrote about \$2,662 in permits for 2023. Mark is waiting on the attorney regarding the zoning map. It may be a couple of weeks. We are waiting on a written opinion from legal regarding the use of the feed mill on Mayburn Barclay. Its purchase is contingent on permitted use. The buyer is aware that he would need to purchase a variance. A Farmdale resident was asked their opinion of a commercial business in Farmdale. They did not have a comment.

Police- Thad told the trustees that his biggest focus for 2024 is on recruitment and retention. He has suggested a \$1 raise for part-time officers and the police secretary. He told the trustees that Rochelle is doing a fantastic job. One person applied for police officer last week. Another person is interviewing on Tuesday. He is putting together a schedule for officers on the road. He asked about benefits for full-time employees. Thad will be putting together a package to offer applicants.

Thad told the trustees that we no longer need Lexipol services. Thad is going through the department's policies.

Greg told the trustees that he is giving up his commission for law enforcement but will continue to help with police events. He also said that Leroy is taking over the organization of the Kinsman Police Golf Outing and is eagerly looking forward to it. Leroy will contact Marti to find dates. Thad told the trustees that he is looking for the right fit for a full-time officer and is not hiring out of desperation. He is doing residential property checks, senior welfare checks, etc.

He will be trying to get Ward North and Ward Christy weight limit enforced. He can do a traffic stop of overweight trucks until the county gets here.

The speed problem in town is drastically worse and traffic stops need to be made.

The trustees are appreciative of Thad's work to get this underway.

Thad told the trustees that he would like to purchase a laser that can measure distance.

The trustees asked Thad if he would be available to attend the Fire meeting at 8 p.m. Tuesday. He will try to be there.

Thad would like to install security cameras in the lobby and locations in the administration building. We will contact Hudson Communications to get a quote.

Thad is unable to attend the reorganization meeting on Monday. Josh is back to his official schedule soon. He may be able to deliver some address signs if he has time. Some people who ordered signs may be older and cannot get out of the house.

Greg said that as discussed in the Special Meeting in December, he has received information back from the Ohio EPA regarding the farmer who buried our natural water way on Ray State Line Road. Trumbull Water and Soil and the Army Corps of Engineers reviewed the problem this caused and has ordered the farmer to return the natural waterway to its original state.

We still have no word on the ARP money from the County.

Greg said we still have about 30 preordered house numbers that have not yet been picked up by homeowners. These house numbers were paid for by the township's ARP fund. Chief Thad Stephenson may have his officers deliver some.

Bruce received a very reasonable quote from the fire association for a garage.

#### **New Business:**

- 1. The trustees are looking into an LED sign to upgrade the current community sign. We have requested the ARP monies from the Trumbull County Commissioners as part of the total request. Additional funds may be donated to help pay for the sign.
- 2. Police- Nothing new to report. The Chief turned in his monthly, quarterly, and yearly reports to the trustees. Thad told the trustees that there was a total of 15 children that participated in Shop with a Cop. The children spent \$299.64 at Ace Hardware, \$955.30 at Dollar General, and \$811 at Family Dollar, all local stores. Over \$4,000 was raised at Tip a Cop fundraiser and \$450.81 was collected in buckets that were located at Ace Hardware, Marathon, and Dollar General.
- 3. Fire-Nothing new.
- 4. Road- Tim sent in his computer this morning to be repaired and will turn in inventory when it returns. They are keeping up with the roads.

Tim told the trustees that his 1999 mower tractor is in decent shape, but the mower itself is in bad shape. The mower head itself is \$75,000 to replace. Tim said that Geauga County Engineers purchased a new one and may sell the used one. We can also call the Trumbull Council of Governments to find out if there is one that can be borrowed. Just the flail head alone is \$21,000.

5. Zoning- Mark gave the trustees his monthly report. He also gave the trustees Melissa Miller's resume to review as she would like to take the spot vacated by Zoning Board Member Angela Murphy. The trustees told the public that the Zoning Board and Zoning Board of Appeals can always use more alternates.
